**III. Welcome**

Dr. Martinez thanked everyone for attending and introduced Mr. Ray York

#### **IV. Discussion Item: Budget Update**

Mr. York convened the EDPAC members for approval on the 2010-11 EWD expenditures plan before it goes to the Board of Governors.

Dr. Erlinda Martinez reported that the Chancellor's Office had been waiting for the budget action. There is an allocation which will be deferred until July 2011 and is not available at this time; therefore it is not reflected in the current allocation of \$22.9 million. This represents the same amount that was received 2009-10 and distribution has remained relatively the same between last year and this year.

Mr. York said that there are new developments that relate to the budget that has an impact on the 2010-11 Expenditure Plan. The budget was signed by the governor and the EWD program did receive the additional allocation of \$25 million for statewide and regional projects. The allocation specifically is to be used for support of ongoing programs, current programs and focus on specific critical industries in which there are skill demands. According to his understanding and advisement, this is an on-going line item. This means that it is an on-going state allocation subject to change through the budget cycle (could increase, decrease or non-funded). This will restore the program back to the original 2008-09 allocation. He stated the problem now being confronted is that the Chancellor's Office is still waiting for final authorization to expend the funds that have been deferred to July 2011. The trailer bill deliberations are still going on. He said this is why this allocation is not in the expenditure plan. It will be added once approved and come forward to EDPAC again. The EDPAC is asked to review and approve the \$22.9 million EWD expenditure plan.

#### **V. Action Item: Discussion and Approval of 2010-11 EWD Budget Expenditure Plan**

Dr. Martinez asked if everyone participating on the call had clear understanding that there were two allocations being discussed. The first item, for the \$25 million allocation, is still waiting on the trailer bills and the second item, for the \$22.9 million, is the 2010-11 EWD expenditure plan that needs EDPAC approval.

Dr. Martinez entertained a motion to approve the 2010-11 EWD budget expenditure plan.

In favor, all ayes.

Opposed, zero nays.

EWD program has budget approval.
